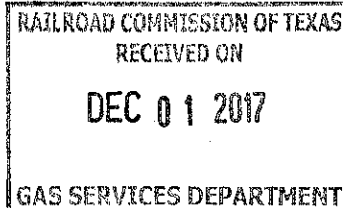

Notes to Table One

Note 1: The Committed Shipper Volume Incentive Rate in Table One shall apply to the barrels of Crude Petroleum that a Committed Shipper tenders in a month at one of the indicated Receipt Points for delivery to the indicated Delivery Point that exceed the Incentive Rate Volume for the month. The Pipeline Operator shall consider all tenders made by a Committed Shipper in a month, whether such tenders are for intrastate or interstate transportation, for purposes of determining if the Committed Shipper has tendered the Incentive Rate Volume in the month. The Incentive Rate Volume shall be the volume of Crude Petroleum equal to 80,000 barrels multiplied by the number of days in the applicable month.

[N] Note 1: The Committed Shipper Volume Incentive Program is available to any shipper ("Committed Shipper") that has entered into a transportation services agreement with Carrier and has committed to ship at least 30,000 barrels per day, on an average basis, during a month over one or more movements set forth in Table Two. Any Committed Shipper that qualifies for the Committed Shipper Volume Incentive

Program will be assessed the rates set forth in Table Two for all qualifying shipments made under the movements set forth in Table Two.

~~[C] Note 1: The Volume Incentive Program listed in Table Two is available for a limited period and may be cancelled by Carrier at any time.~~

~~Note 2: Any shipper that ships in greater than 35,000 barrels per day ("BPD"), on an average basis, during a month over one or more of the movements set forth in Table Two ("Qualifying Shipments") qualifies for the Temporary Volume Incentive Program in Table Two. Any shipper that qualifies for the Temporary Volume Incentive Program during a month will be assessed the rates set forth in Table Two for all of the Qualifying Shipments that the shipper makes during the month. The shipper will pay the applicable rates set forth in Table One for any of its movements that are not Qualifying Shipments or if it does not qualify for the Temporary Volume Incentive Program.~~

~~Note 3: If a shipper qualifies for the Temporary Volume Incentive Rates in Table Two in a month, Carrier will apply the rates to a shipper's Qualifying Shipments in progressive order. For example, a shipper that ships an average of 85,000 BPD of Qualifying Shipments in a shipment month will be charged the following rates for its Qualifying Shipments: (i) 135.00 cents for the first 35,000 BPD, (ii) 63.00 cents for the next 45,000 BPD, and (iii) 60.00 cents for the next 5,000 BPD.~~

UNLOADING CHARGE (applicable to all movements under this tariff): All shipments unloaded by tank truck into the mainline facilities will be subject to a charge of [U] eight cents (\$0.08) per barrel in addition to the transportation rates named here.
