In any given month, for each barrel delivered over a daily average rate of 62,500 barrels per day but less than the daily average rate of 72,000 barrels per day, there shall be an incremental power fee of [U] forty-five cents (\$0.45) per barrel in addition to the transportation rates named herein.

In any given month, for each barrel delivered over a daily average rate of 72,000 barrels per day, there shall be an incremental power fee of [U] fifty cents (\$0.50) per barrel in addition to the transportation rates name herein.
